Research topic: "The economic analysis of social classes: a Classical approach".

The aim of this work is to combine the analysis of social classes in Europe according to the functional distribution of incomes with a gender perspective at household level. Building on a Classical political economy approach, we have explored the link between households' sources of income (distinguishing rents, profits and wages) and income changes during the crisis. Furthermore, we emphasized the role of gender in influencing the position of families in the distribution of incomes. The empirical investigation has been carried out on EU SILC- European Statistics on Income and Living Conditions- database, both in the longitudinal and cross sectional formats, at household and individual level. Finally, a first attempt of measuring income vulnerability at household level according to the capital/wage endowment has been carried out applying the Chaudhuri (2002)'s methodology on cross-sectional data.
